## Request for Proposals for MMIP Training

**Project Details:**

The Santa Rosa Rancheria Tachi Yokut Tribe (Tribe) is requesting training and assistance from qualified professional contractors (Contractor) in multiple fields of Missing and Murdered Indigenous People (MMIP). In 2024, the Tribe received a Missing and Murdered Indigenous People (MMIP) grant from the California Board of State and Community Corrections program to fund MMIP initiatives for the Tribe. Specifically, fields of recognizing and responding to possible MMIP events that may be occurring on the Tribal reservation.

The Tribe is interested in retaining MMIP services and expertise for events as follows:

- 12-15 small classes/sessions in multiple MMIP areas - less than 25 participants/per event
  - Small room settings lasting between 1-2 hours.
  - Targeting Tribal members and community members on the reservation.
  - Sessions anticipated to be held every 1-3 months on the reservation.
- Two large events in multiple MMIP areas - anticipating 50-500 participants/per event
  - Large conference type event planned for 1-2 days.
  - Participation, sessions, and training exercise(s) in MMIP conference.
  - 2026/2027 dates to be determined.
  - Conference details to be planned and determined.
- Two-to-four small MMIP training courses (15-30 staff) for Tribal government, administrative, casino, and gas station staff members.
  - One focus area of “train the trainer” for staff to be able to train other staff members of recognizing MMIP scenarios.
  - Dates to be determined and to be held on the reservation.

**The Tribe and Contractor shall coordinate via phone, email, and in person meetings regarding training sessions, event dates, and event activities to be completed by December 31, 2027. Onsite Contractor participation is expected for events listed.**

**RFP Response:**

If interested, please submit a proposal outlining available MMIP related services for staff training and general community courses, qualifications, and costs associated with aiding the project.

Please submit RFP response as follows;

1. Introduction letter and response to Tachi MMIP RFP project areas.
2. Qualifications for providing assistance in MMIP for purposes of community events and training staff.
3. Qualifications of company or specific consultant/staff who will assist project in fields of MMIP.
4. Total bid cost and outline for contract services.

**Submission Instructions:**

Bids must be submitted electronically to the RFP Contact listed above, no later than 5:00 PM (PT), on February 20, 2026. The subject line should read: **RFP Tachi MMIP.**

**Late Submission:**

Proposals submitted after RFP date and time deadline shall not be considered.

**Selection of Contractor:**

Tribal Council, Administrative staff, and MMIP project staff shall review all qualified bids to make a final determination by **February 25, 2026.**

**Contractor Award Notification:**

The Tribe shall notify accepted bid/Contractor on February 25, 2026. The Tribe shall enter into a formal contract agreement. Contractor shall be expected to begin immediately upon selection and will coordinate with Tribes' MMIP staff via phone, email, and in person meetings for duration of contract. Contract services shall end at the final event.
