Position to be filled: Crisis Worker

Required Qualifications/Essential Duties:

- Must have Associate Degree in Human Services, Social Studies, or Psychology; plus two years' experience within a crisis or Human/social service field **Required;**
- Must be insurable through company's carrier and maintain throughout employment – Required
- Must have Valid California Drivers' License;
- Crisis response is designated for Tachi-Yokut Tribal Members only within the Santa Rosa Rancheria reservation;
- Practice the Tachi-Yokut culture, and established Tribal/Departmental policy and procedures;
- Awareness of /ability to learn appropriate laws, regulations pertaining to the Indian Child Welfare Act (ICWA) Ashlyne Mike AMBER Alert in Indian Country Act of 2018;
- Maintains client/tribal member records according to HIPPA and 42 CFR. Adhere to all confidentiality standards;
- Provide telephone crisis and suicide risk evaluations; Provide crisis intervention;
- Communicate regularly with client families as required to provide needed support;
- Provide case management for the family as needed;
- Know resources within the tri-county area;
- Provide crisis evaluation, intervention, and counseling to those in crisis;
- Willingness to work various hours as the program operates 24 hours a day, 365 days a year;
- Have the willingness to be trained on evidenced base suicide and crisis intervention techniques;
- Have the willingness to be trained on evidenced base Native American Domestic Violence interventions;
- Provide transportation for victims of domestic violence to a safe and secure location;
- Ensure appropriate and comprehensive documentation within an EHR system;
- Have the ability to work with Tribal Public Safety and emergency first responders who will be called for active rescue and welfare checks;
- Perform related work appropriate to the classification assigned; other duties as assigned;
- Drive company vehicles or personal vehicle to conduct business on behalf of the Tribal Social Services Department.
